

# VERIFICATION STATEMENT WATER WITHDRAWAL

Bureau Veritas North America (BVNA) was engaged to provide Limited Assurance and conduct an independent verification of the water withdrawal reported by Symantec Corporation (Symantec) for the period stated below. This Verification Statement applies to the related information included within the scope of work described below.

The determination of the water withdrawal is the sole responsibility of Symantec. BVNA was not involved in determining the water withdrawal. Our sole responsibility was to provide independent verification on the accuracy of the water withdrawal information reported, and on the underlying systems and processes used to collect, analyze and review the information.

### Boundaries of the reported data covered by the verification:

- Operational Control
- Worldwide
- Exclusions from the scope of the reporter's data assertion:
  - Data outside the defined assurance period of fiscal year 2014 (April 1, 2013-March 31, 2014)
  - o Water withdrawal at sites where metered data was not available to Symantec

• Water Withdrawal: 350.75 megaliters

Based on the results of our verification process, BVNA provides Limited Assurance of the water withdrawal assertion shown above, and found no evidence that the assertion:

- is not materially correct;
- is not a fair representation of the water withdrawal data and information; and
- has not been prepared in accordance with the CDP Project Guidance for Companies, for Corporate Reporting on Water on Behalf of Investors and Supply Chain Members.

It is our opinion that Symantec has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of water withdrawal for the stated period and boundaries.
